1. Integrity and transparency guide our every decision **business litigation lawyer** Risk management. Understand the minimum wage rate – Utah has a uniform minimum wage rate that must be paid to all employees regardless of job title or experience level.
2. Ensure overtime pay – The state requires employers to pay their employees 1 ½ times their normal hourly rate for all hours worked over 40 per week or 8 per day.

3. Comply with child labor laws – Employees under 18 years old must adhere to different rules than adult workers; employers must be sure they follow all relevant regulations when it comes to hiring minors.

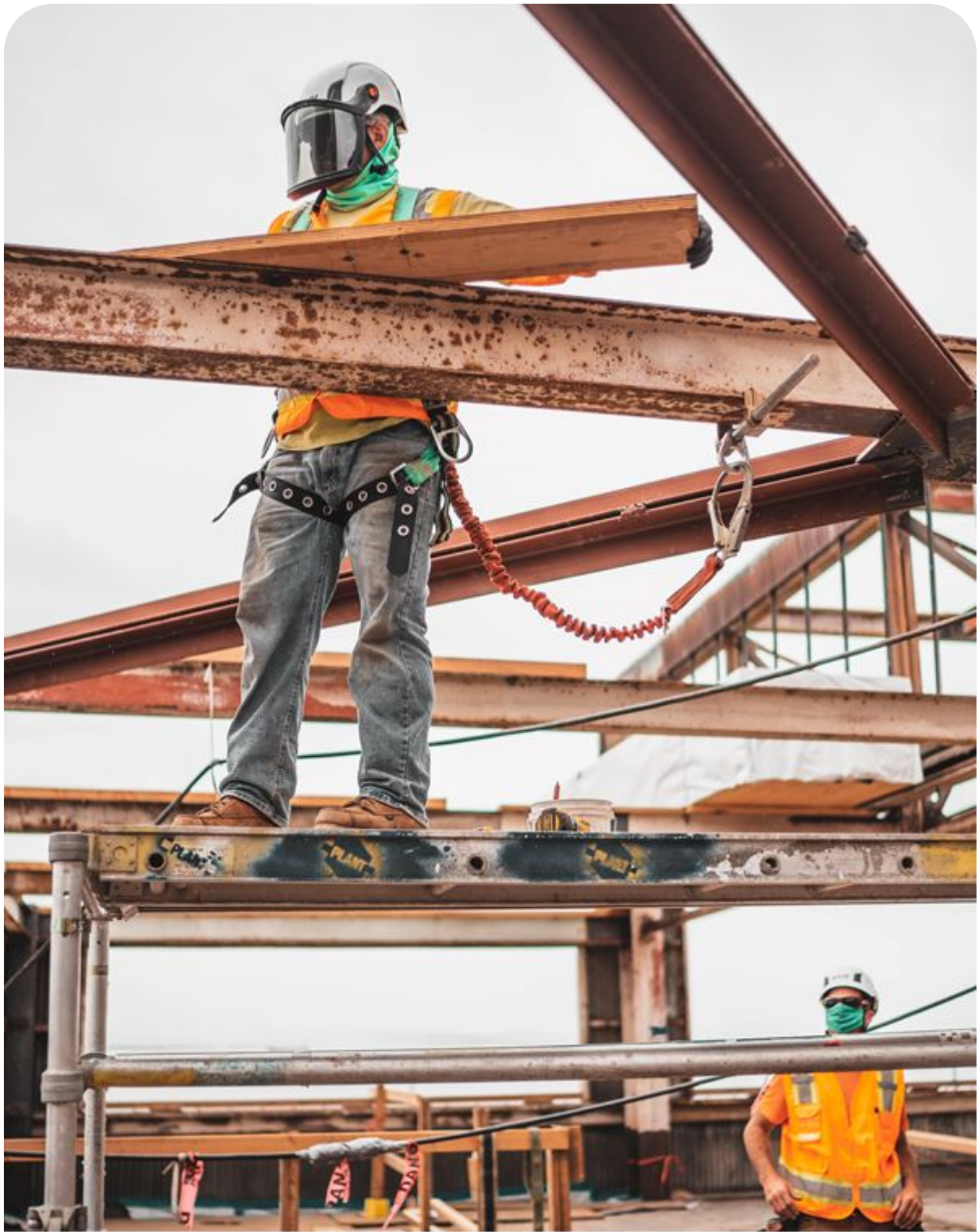

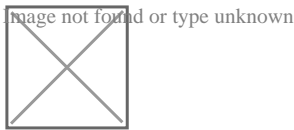
